

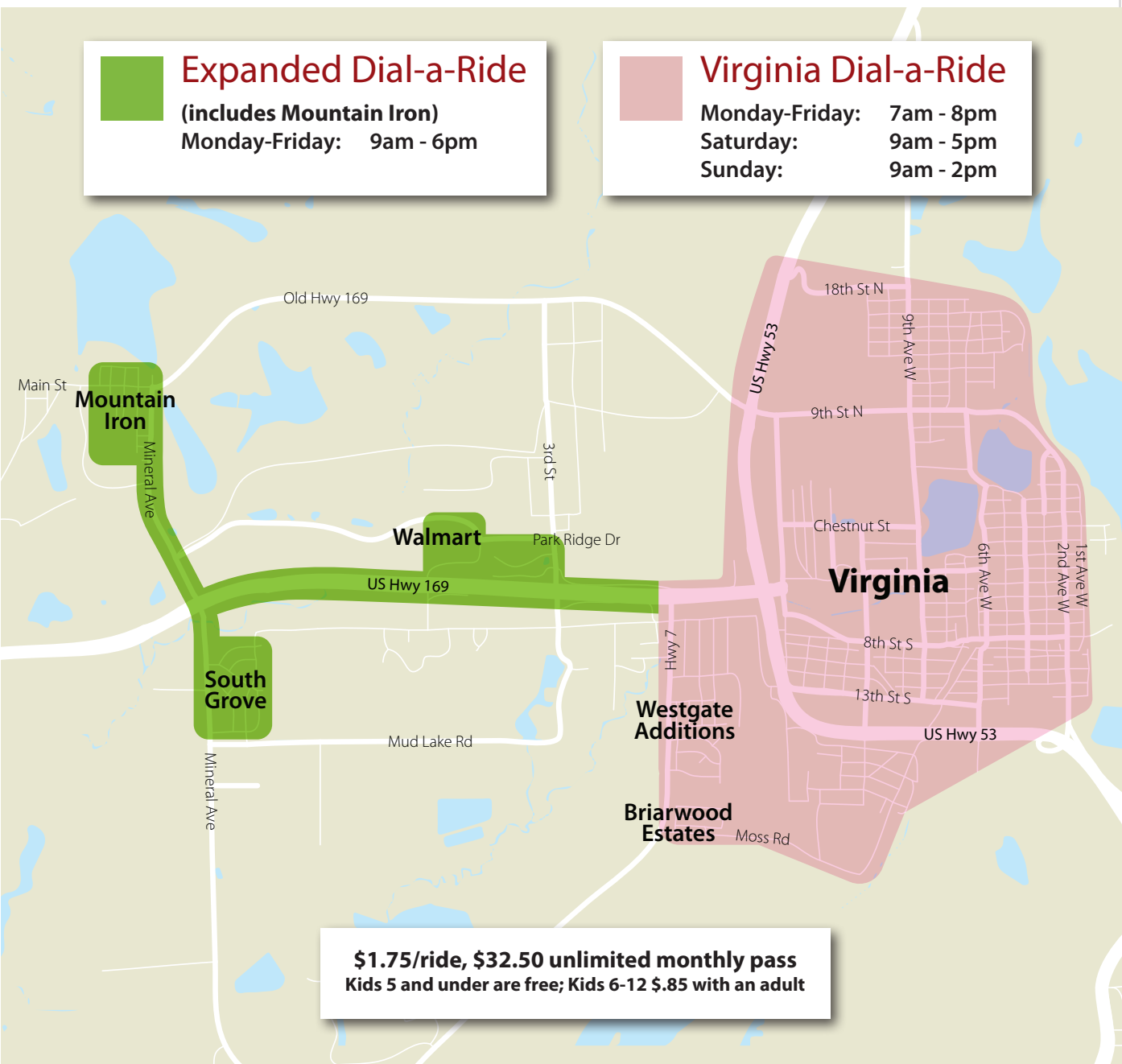

Arrowhead Transit (AEOA) hereby gives public notice of its policy to uphold and assure full compliance with Title VI of the Civil Rights Act of 1964, the Civil Right Restoration Act of 1987 and all related statutes.
