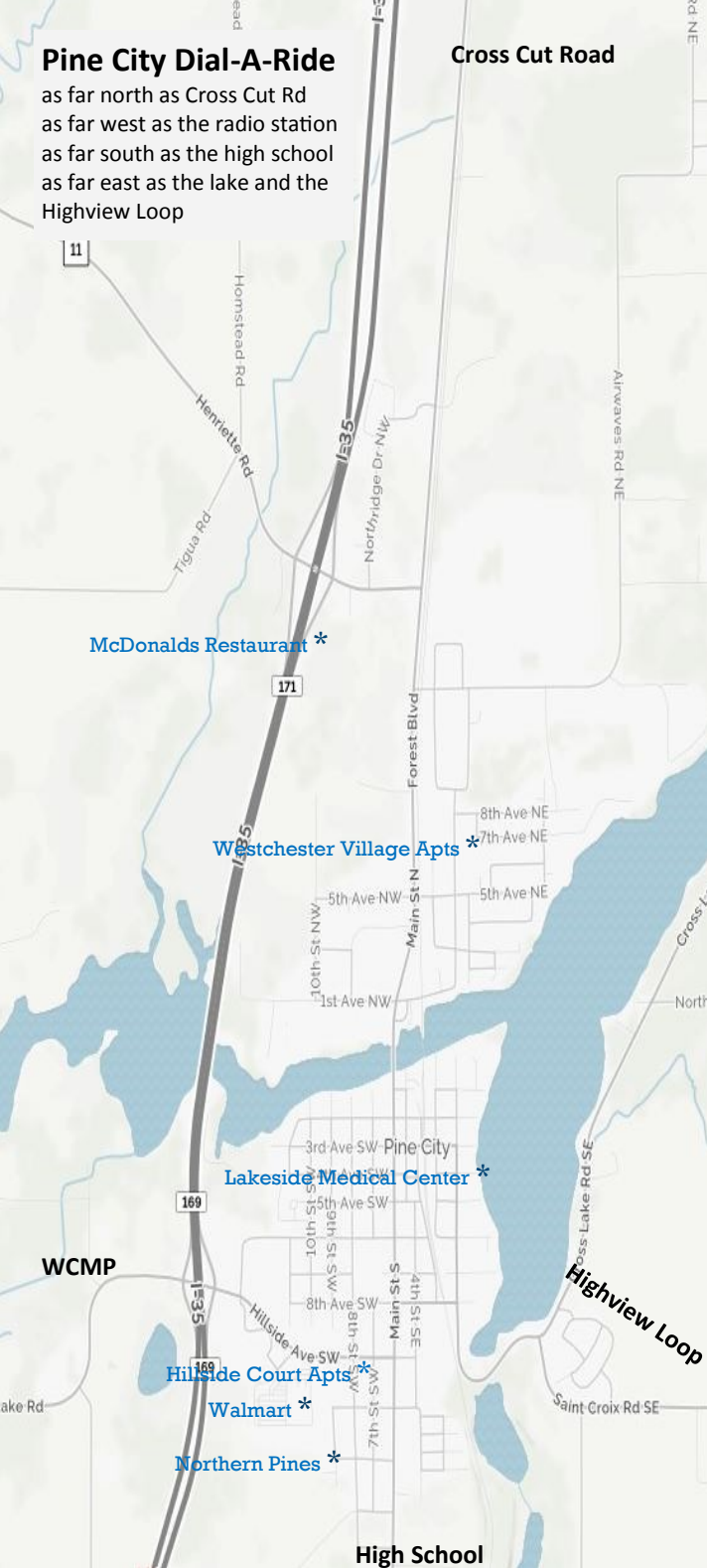

## Pine City Dial-A-Ride

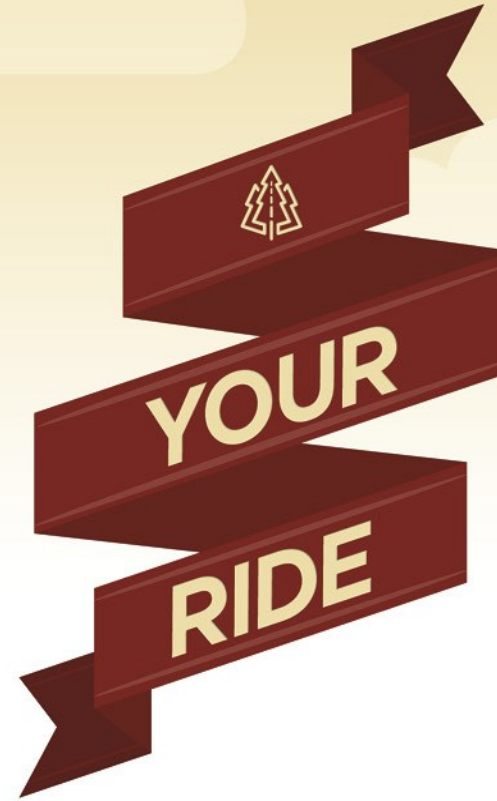
